AUTHOR LICENCE AND DECLARATION

1 Introduction

In order for the Church Monuments Society to ensure the widest possible dissemination of material published under its auspices, the Society will, under the conditions laid out below, permit an author to post a copy of an article or articles written by themselves in a free to use on-line repository. This decision was taken at a Meeting of Council on 5th March 2016.

2 Licence and Applicability

Permission is given under a Creative Commons Attribution-NonCommercial-NoDerivatives 4.0 Licence (CC BY-NC-ND 4.0) and applies to articles published in all issues of the *Bulletin of the International Society for the Study of Church Monuments* and the *Church Monuments Society Newsletter*, together with volume 1 part 1 to volume 27 inclusive of *Church Monuments*. The Society asserts that it owns the copyright in the typographical arrangement and artistic craftsmanship of the specified volumes and will allow authors agreeing to and complying with the terms of the CC BY-NC-ND 4.0 Licence to post a copy of the published version or versions of their own article or articles on a free to use online repository. The Licence covers the typographical arrangement and artistic craftsmanship alone. It excludes all other rights, including those of authors and artists.

No commercial use may be made of any version of the paper archived under these provisions nor may derivatives be shared. The full text of the CC BY-NC-ND 4.0 Licence is available at <u>https://creativecommons.org/licenses/by-nc-nd/4.0/legalcode</u> and a summary of the provisions is available at <u>https://creativecommons.org/licenses/by-nc-nd/4.0/</u>. The Society advises authors wishing to take advantage of this Licence to consult these documents in advance.

3 Authors' Responsibilities

It is the responsibility of the author posting the article to ensure that their action breaches no laws, including copyright and, where necessary, it is their responsibility to ensure that third party rights clearances are in place. This is most likely, but not exclusively, to apply to the use of images and textual quotations. For this purpose, permission is required for use in digital formats, in perpetuity and world-wide. If the article was written by more than one person, permission should also be obtained from all co-authors.

A CC BY-NC-ND 4.0 Licence requires that material posted under its provisions should be attributed. Consequently, the article or articles must be accompanied by a clear and prominent publication reference (the name of the publication, its issue number and date of publication) together with a link to the Society's website and a note that the Society has licenced its rights in the typographical arrangement and artistic craftsmanship under a Creative Commons Attribution-NonCommercial-NoDerivatives 4.0 Licence.

Please note that the Licence terminates automatically if these provisions are not fulfilled.

4 Time Period and Attribution

The Licence is available after a period of one year has elapsed since the publication of the article.

5 Authors' Warranty

The author posting the article or articles warrants to the Society that they have obtained in advance the permission of any co-authors and ensured that any material contained in the article that is subject to third party rights is covered by a relevant licence from the third party or parties.

The author posting the article or articles shall indemnify and hold the Society harmless against all and any loss, damages, liability and costs (including reasonable legal expenses) that the Society suffers or incurs as a result of, or in connection with, any breach by the author of the warranty above.

At the request of the Society and at the author's own expense, he or she shall provide all reasonable assistance to enable the Society to resist any claim, action or proceedings brought against the Society as a consequence of that breach.

6 Procedure

Each author wishing to take advantage of the permission should download a copy of this document, complete the details below, sign it, date it and send it to the Editor of *Church Monuments* at the time of signature.
